
The Telangana State Pollution Control Board after examining the application, and the Inspection report hereby issues Certificate of Registration to M/s ITC Ltd., PSPD, Bollaram, Jinnaram Mandal, Sangareddy District under Rule, 13 (1) of Plastic Waste Management Rules, 2018 for manufacturing of PLA Laminated Paper Boards . (Compostable/Bio-degradable) (Or) Polyethylene Laminated Paper Boards - 200TPD & Sheeting and Rewinding of Paper & Paper Boards - 100TPD.

The certificate is granted subject to the following conditions:

- The industry shall not change the product without obtaining CFE/CFO/Registration of TSPCB.
- The industry shall not manufacture, stock, distribute or sell any carry bag made of virgin or recycled or compostable plastic, which is less than 50 microns in thickness.

- 3. The industry shall manufacture carry bags either "in natural shade (colourless) which is without any added pigment" or by using only those pigments and colourants which are in conformity with Indian Standard: IS 9833:1981 titled as "List of pigments and colourants for use in plastics in contact with foodstuffs, pharmaceuticals and drinking water", as amended from time to time.
- carry bags made of recycled plastics or products made of recycled plastics shall not be used for storing, carrying, dispensing or packaging ready to eat or drink food stuffs.
- 5. The industry shall not use sachets made by using plastic material for storing, packing or selling gutkha, tobacco and pan masala;
- 6. The industry shall not supply plastic material/plastic rolls to any manufacturer/packing agency /distributor/trader etc., to pack gutkha, tobacco and pan masala;
- 7. The industry shall manufacture recycled carry bags in conformity to the Indian Standard: IS 14534:1998 titled as Guidelines for Recycling of Plastics, as amended from time to time.
- 8. The industry shall manufacture compostable plastic carry bags in conformity to the Indian Standard: IS/ISO 17088:2008 titled as specifications for Compostable Plastics, as amended from time to time.
- Manufacturers of plastic carry bags and multilayered plastic pouch or sachets print the following information in English or in local language, namely.
 - i. Name, registration number of the manufacturer and thickness in case of carry bag;
 - ii. Name and registration number of the manufacturer in case of multilayered plastic pouch or sachets.
 - iii. Name and certificate number [Rule 4(h) of PWM Rules, 2016] in case of carry bags made from compostable plastic.
- 10. Manufacturers of recycled carry bags shall label or a mark "recycled" as shown below:

NOTE: PET-_Polyethylene terephthalate, HDPE-High density polyethylene, V-Vinyl (PVC), LDPE- Low density polyethylene, PP-Polypropylene, PS-Polystyrene and other means all other resins and multi-materials like ABS (Acrylonitrile butadiene styrene), PPO (Ployphenlene oxide),PC (Polycarbonate),PBT (Polybutylene terephalate) etc.,

- 11. The industry shall establish waste collection system based on "Extended producer's responsibility (EPR)" involving State Urban Development Departments, either individually or collectively, through their own distribution channel or through the local body concerned.
- 12. Manufacturers of compostable plastics carry bags shall label a mark "compostable".
- 13. Manufacture and use on non-recyclable multilayered plastic if any should be phased out in two years time.
- 14. The industry is responsible for collection of used Multilayered Plastic Sachets or Pouches or packaging who introduce the product in the market. They need to establish the system for collecting back the plastic waste generated due to their product.
- 15. The industry shall reuse the plastic waste generated during the process or sell the plastic waste only to the plastic recycling units registered with Telangana State Pollution Control Board.
- 16. Every producer shall maintain a record of details of the person engaged in supply of plastic used as raw material to manufacture carry bags or plastic sheet or like or cover made of plastic sheet or multilayered packaging.

- 17. The industry shall apply for renewal of registration at least 120 days before the expiry of the validity of the registration certificate.
- 18. The industry shall apply renewal the 'CFO' order at least '120' days before the expiry of existing 'CFO' order.
- 19. The Board may at anytime revoke or suspend registration for any violation of provisions of the Rules.
- 20. The industry shall follow all the provisions of Plastic Waste Management Rules, 2016. Any violation of provisions of these Rules and amendments thereof will attract the penal provision of the Environment (Protection) Act, 1986.

This certificate of registration shall be **valid up to 31.03.2033** unless revoked or suspended.
